Financial Ratio Analysis to Measure the Performance of Retail Companies in the Supermarket and Minimarket Subsectors Listed on the Indonesia Stock Exchange (2020–2022)

Abstract: -This study analyzes the financial reports of retail companies in the supermarket and minimarket subsector listed on the Indonesia Stock Exchange, focusing on Liquidity, Solvency, Activity, and Profitability ratios. The data, consisting of balance sheets and income statements, are sourced from the Indonesia Stock Exchange for the 2020–2022 period and collected using documentation techniques. The analysis results indicate that PT Indoritel Utama International Tbk has the best liquidity ratio, with an average current ratio of 461% and cash ratio of 23% over three years. This company also exhibits the best solvency ratio, with a debt to assets ratio of 37% and a debt to equity ratio of 37%. Regarding activity ratios, PT Sumber Alfaria Trijaya Tbk has the strongest financial position, with an assets turnover of 305%. In terms of profitability, PT Sumber Alfaria Trijaya Tbk also leads with a return on equity of 20.2% and a return on investment of 6.9%, while PT Midi Utama Indonesia Tbk records the highest return on assets at 17%.

1 Introduction

Financial problems are one of the most important and primary problems for companies in business development in all companies.(Triyonowati, 2022). One of the aims of establishing a company is to obtain maximum profit.(Triyonowati, 2022). However, the success or failure of a company in seeking finance and maintaining the company depends on financial management. The company must have good and efficient financial

performance to maintain profits for the sustainability of the company's operations. (Triyonowati et al., 2023).

Companies that are experiencing development or growth cannot be seen only from the expansion or development of buildings, because it is possible that the company is financing the expansion through company liabilities. (Triyonowati et al., 2022). To find out the actual development of a company, an analysis needs to be done, so that it can be known whether the company's performance is good or not. Companies need to conduct financial report analysis because financial reports are used to assess company performance, and are used to compare the company's condition from previous years to the current year whether the company has improved or not, so that the company can consider the decisions to be taken for the coming year in accordance with the company's existing performance. (Jaya, 2019). So, company performance is a process of critically reviewing the company's finances to provide solutions in making the right decisions in a certain period.

Ratio analysis is one method that can be used to analyze and interpret information contained in financial reports. (Triyonowati, 2022). With ratio analysis, the condition of a company's financial position can be known, whether its financial position is good or bad, and it can show the performance that the company has achieved in a certain period. (Lisiantara & Febrina, 2018; Rasyid, 2018). By analyzing a company's financial report, everyone who has an interest in the company can find out the developments experienced by the company. (Rasyid, 2018; Vestari & Farida, 2014). To provide a clearer picture, the author chose retail companies in the supermarket and minimarket subsectors listed on the Indonesia Stock Exchange as research objects.

Previous studies have shown the relationship between ratio analysis and company financial performance, but the results are still diverse and inconsistent so that further research is needed to examine in depth the financial ratio analysis of the performance of retail companies in the supermarket and minimarket subsector on the Indonesia Stock Exchange. The purpose of this study is to analyze the financial health of companies with a focus on the Liquidity, Solvency, Activity, and Profitability ratios in retail companies in the supermarket and minimarket subsector listed on the Indonesia Stock Exchange. In this study, the author uses a descriptive analysis method through literature. The data that has been obtained is then calculated using the financial ratio formulas of liquidity ratio, solvency ratio, activity ratio, and profitability ratio.

2 Theoretical Framework

Financial statement analysis is essentially aimed at providing a more appropriate and systematic basis for consideration in order to predict what might happen in the future, considering that the data presented by the financial statements describe what has happened. In addition, financial statement analysis will also be able to reduce and narrow various uncertainties and can provide a basis for consideration regarding the potential success of the company in the future.

In general, there are two methods of financial statement analysis that are commonly used in practice, namely Vertical analysis is an analysis that is carried out only on one financial statement period. This analysis is carried out between items in the financial statements from one period. So, the information obtained only describes the key relationships between financial statement items or conditions for one period only so that it cannot know the development of the company's

condition from one period to the next. Vertical analysis can also be a comparative analysis of the financial statements of the Jain company in a certain time period, where the comparison is made against similar information from other companies in the same industry or associated with industry data (as a benchmark) in the same time period(Triyonowati, 2022). Next, Horizontal analysis is an analysis conducted by comparing financial statements from several periods. In other words, the comparison is conducted with similar information from the same company (the company itself) but for different time periods. Through the results of this analysis, the progress or decline of the company's performance from one period to the next can be seen. (Triyonowati, 2022).

To perform financial ratio analysis, it is necessary to calculate financial ratios that reflect certain aspects. Financial ratios may be calculated based on the figures in the balance sheet only, in the income statement only, or on the balance sheet and income statement. Each financial analysis may formulate certain ratios that are considered to reflect certain aspects. If the analysis is carried out by the creditor, the aspects assessed will be different from the assessments made by prospective investors. Overall, the aspects assessed are usually classified into leverage aspects, liquidity aspects, profitability or efficiency aspects, and market value ratios. (Triyonowati, 2022).

3 Research Method

This research is a quantitative research using a descriptive statistical approach. The population in this study is the supermarket and minimarket sub-sector retail companies listed on the Indonesia Stock Exchange during the 2020-2022 period consisting of 6 (six) companies for 3 years. Meanwhile, the sampling method used is purposive sampling. Purposive sampling is a sampling technique based on certain criteria or considerations.(Jaya, 2020).

The data analysis technique that the author uses is to calculate the ratios that exist in the company.

a. Liquidity Ratio

This ratio measures the company's ability to meet its maturing liabilities, both liabilities to external parties and within the company.

b. Solvency Ratio

This ratio measures the company's ability to meet its maturing liabilities, both liabilities to external parties and within the company.

This ratio is used to measure the effectiveness of a company in using its assets. Or it can also be said that this ratio is used to measure the level of efficiency (effectiveness) of the company's resource utilization.

a) In 2020, the Current Ratio of PT Sumber Alfaria Trijaya Tbk. was 0.88 or 88%, which means that every Rp1.00 of current liabilities will be guaranteed by Rp0.88 of current assets. PT Midi Utama Indonesia Tbk. was 0.65 or 65%, which means that every Rp1.00 of current liabilities

- will be guaranteed by Rp0.65 of current assets. PT Indoritel Makmur International Tbk. was 7.93 or 793%, which means that every Rp1.00 of current liabilities will be guaranteed by Rp7.93 of current assets.
- b) In 2021, the Current Ratio of PT Sumber Alfaria Trijaya Tbk. was 0.87 or 87%, which means that every Rp1.00 of current liabilities will be guaranteed by Rp0.87 of current assets. PT Midi Utama Indonesia Tbk. was 0.68 or 68%, which means that every Rp1.00 of current liabilities will be guaranteed by Rp0.68 of current assets. PT Indoritel Makmur International Tbk. was 4.71 or 4.71%, which means that every Rp1.00 of current liabilities will be guaranteed by Rp4.71 of current assets.

PT Midi Utama Indonesia Tbk. was 2.13 or 213%, meaning that the asset turnover in one year was 2.13 times. PT Indoritel Makmur International Tbk. was 0.04 or 4%, meaning that the asset turnover in one year was 0.04 times.
- b) In 2021, ATO of PT Sumber Alfaria Trijaya Tbk. was 3.09 or 309%, meaning that the asset turnover in one year was 3.89 times. As much as 0.031 or 3.1% means that every Rp. 1.00 of total assets can generate a net profit of Rp. 0.031.

As much as 0.087 or 8.7% means that every Rp. 1.00 of total assets can generate a net profit of Rp. 0.087.
- c) In 2022, the ROE of PT Sumber Alfaria Trijaya Tbk. was0.253 or 25.3% means that every Rp. 1.00 of total assets can generate a net profit of Rp. 0.253. PT Midi Utama Indonesia Tbk. As much as 0.202 or 20.2% means that every Rp. 1.00 of total assets can generate a net profit of Rp. 0.202. PT Indoritel Makmur International Tbk. As much as 0.110 or 11% means that every Rp. 1.00 of total assets can generate a net profit of Rp. 0.110.

Based on the table of ROI analysis results for retail companies in the supermarket and minimarket sub-sectors listed on the Indonesian Stock Exchange, it is known that:

- a) In 2020, the ROI of PT Sumber Alfaria Trijaya Tbk was 0.041 or 4.1%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.041. PT Midi Utama Indonesia Tbk. was 0.041 or 4.1%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.041. PT Indoritel Makmur International Tbk. was 0.027 or 2.7%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.027.
- b) In 2021, the ROI of PT Sumber Alfaria Trijaya Tbk was 0.072 or 7.2%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.072. While PT Midi Utama Indonesia Tbk. was 0.043 or 4.3%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.043. PT Indoritel Makmur International Tbk. was 0.052 or 5.2%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.052.
- c) In 2020, the ROI of PT Sumber Alfaria Trijaya Tbk was 0.094 or 9.4%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.094. While PT Midi Utama Indonesia Tbk. was 0.059 or 5.9%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.059. PT Indoritel Makmur International Tbk. was 0.069 or 6.9%, meaning that every Rp. 1.00 of net profit generated assets of Rp. 0.069.

Discussions

Analysis of the current ratio and cash ratio of three retail companies in the supermarket and minimarket sub-sector on the Indonesia Stock Exchange (2020-2022) shows that:

1. PT. Sumber Alfaria Trijaya Tbk

- Current Ratio: Average 0.89 (not yet liquid). Slight fluctuation, with an increase in 2022 due to the increase in current assets being greater than current liabilities.
- o Cash Ratio: Average 0.22 (not liquid). Up and down every year, but still below 1.

2. PT Midi Utama Indonesia Tbk

- o Current Ratio: Average 0.69 (not liquid). Increasing every year, but still below 1.
- Cash Ratio: Average 0.08 (not liquid). Up and down every year, still low.

3. PT Indoritel Makmur International Tbk

- Current Ratio: Average 4.61 (liquid). Dropped sharply from 7.93 (2020) to 1.20 (2022), but remains above 1.
- Cash Ratio: Average 0.23 (not liquid). Up and down every year, with a drastic drop in 2022.

Overall, PT Indoritel Makmur International Tbk is the company with the best liquidity based on the current ratio. However, all three companies have cash ratios that are still below 1, indicating challenges in paying off short-term debt with only available cash.

1. Debt to Asset Ratio (DAR)

o PT. Sumber Alfaria Trijaya Tbk experienced a decrease in DAR from 71% (2020)

- to 62% (2022), with an average of 66%. This decrease was due to a greater increase in assets compared to liabilities.
- PT Midi Utama Indonesia Tbkalso experienced a decrease in DAR from 76% (2020) to 71% (2022), with an average of 73%. This decrease indicates better asset management, although it is still above 50%.
- PT Indoritel Makmur International Tbkhave a lower DAR, down from 40% (2020) to 34% (2022), with an average of 37%, indicating healthier financial conditions.
- The ideal DAR is below 50%. PT Indoritel Makmur International Tbk is considered better than the other two companies which are still above 50%.

2. Debt to Equity Ratio (DER)

- o **PT. Sumber Alfaria Trijaya Tbk** has a DER that decreased from 240% (2020) to 168% (2022), with an average of 204%.
- PT Midi Utama Indonesia Tbkalso experienced a decline from 323% (2020) to 247% (2022), with an average of 287%.
- PT Indoritel Makmur International Tbkhas a lower DER, down from 69% (2020) to 60% (2022), with an average of 60%.
- A lower DER indicates the company is better able to cover its liabilities with equity.
 PT Indoritel Makmur International Tbk has the best ratio because it is below 100%.

Overall, PT Indoritel Makmur International Tbk has the healthiest financial condition among the three companies because its DAR and DER are lower. Meanwhile, PT Sumber Alfaria Trijaya Tbk and PT Midi Utama Indonesia Tbk still have quite high levels of liabilities compared to their assets and equity.

From 2020-2022, PT Sumber Alfaria Trijaya Tbk showed efficient performance in utilizing its assets with an Average Total Asset Turnover (ATO) of 3.05 (305%), always above 2.5. Its asset turnover has increased every year, with the highest increase in 2021 of 0.17 or 17%, driven by sales growth that was greater than the increase in assets.

PT Midi Utama Indonesia Tbk also experienced an increase in ATO every year, but still below 2.5, with an average of 2.17 (217%). The largest increase occurred in 2022 at 0.12 or 12%. Although close to a good figure, the company needs to continue to improve its efficiency. In contrast, PT Indoritel Makmur International Tbk has a much lower ATO, with an average of only 0.07 (7%). Although there is an increase every year, the value is still too small, indicating a lack of efficiency in utilizing assets. This company needs to increase its sales significantly to be more optimal. Overall, PT Sumber Alfaria Trijaya Tbk is the company with the best performance, because it has the highest ATO ratio and is above the standard of 2.5, indicating good efficiency in using assets.

From 2020 to 2022, the three retail companies in the supermarket and minimarket sub-sector listed on the Indonesia Stock Exchange experienced an increase in Return on Assets (ROA), which shows their efficiency in generating profits from their assets.

- **PT. Sumber Alfaria Trijaya Tbk** has an average ROA of 15.3% over three years, with a gradual increase from 5.3% (2020) to 11.7% (2022). The increase in profit is greater than the assets, making this ratio quite good.
- **PT Midi Utama Indonesia Tbk**also experienced an increase in ROA, from 4.5% (2020) to 7.3% (2022), with an average of 17% over three years. Although the increase is stable, this ratio is still in the good category because it is above 5%.
- **PT Indoritel Makmur International Tbk**recorded an increase in ROA from 1.9% (2020) to 7.3% (2022), but the three-year average was only 4.9%, which is still below the 5% standard, indicating less than optimal efficiency in asset utilization.

Overall, PT Midi Utama Indonesia Tbk is considered the healthiest based on ROA, followed by PT Sumber Alfaria Trijaya Tbk which also has a good ratio, while PT Indoritel Makmur International Tbk still needs to improve its efficiency in generating profits from its assets.

From 2020 to 2022, PT Sumber Alfaria Trijaya Tbk showed an increasing trend in Return on Equity (ROE) from 14.2% to 25.3%, with a three-year average of 20.2%, which is considered good because it is above the standard of 8.32%. PT Midi Utama Indonesia Tbk also experienced an increase in ROE from 17% to 20.2%, with an average of 18.1%, which is also considered healthy. Meanwhile, PT Indoritel Makmur International Tbk experienced an increase from 3.1% to 11%, but its three-year average was only 7.6%, still below the standard of 8.32%, so it is considered not optimal. Overall, PT Sumber Alfaria Trijaya Tbk has the best performance in generating returns from its equity during the 2020-2022 period.

From 2020 to 2022, PT Sumber Alfaria Trijaya Tbk showed an increase in Return on Investment (ROI) from 4.1% to 9.1%, with a three-year average of 6.9%, which is considered good because it is above the 5% standard. PT Midi Utama Indonesia Tbk experienced an increase from 4.1% to 5.9%, but its three-year average of 4.7% is still below the standard. PT Indoritel Makmur International Tbk also increased from 2.7% to 6.9%, with an average of 4.9%, which also has not reached the 5% standard. PT Sumber Alfaria Trijaya Tbk has the best performance in managing net profit to generate assets during the 2020-2022 period.

5 Conclusions

Based on the analysis of the financial ratios of retail companies in the supermarket and minimarket sub-sector listed on the Indonesia Stock Exchange in 2020-2022, PT Indoritel Makmur International Tbk has the best liquidity and solvency ratios with an average current ratio of 461%, cash ratio of 23%, debt to assets ratio of 37%, and debt to equity ratio of 37%. Meanwhile, PT Sumber Alfaria Trijaya Tbk showed the best performance in the activity ratio with assets turnover of 305% and in the profitability ratio with a return on equity of 20.2% and a return on investment of 6.9%. PT Midi Utama Indonesia Tbk recorded the highest return on assets of 17%. To improve financial performance, companies are advised to reduce long-term liabilities, increase assets, and improve liquidity ratios so that profitability is more optimal. Further research is advised to extend the observation period, add financial performance variables, and expand the population and research samples.
